On February 14th, the Governor presented his budget proposal to the New Hampshire Legislature. This budget contains his public policy priorities over the next two years and begins the Legislative Phase of the State Budget. This webinar will examine what we know so far about the Governor's budget proposal for State Fiscal Years 2024 and 2025.

### **Understanding the House Finance Committee's Proposal**

The House Finance Committee has been working to understand and plan modifications to the Governor's State Budget proposal since it was released. The House Finance Committee's version of the State Budget will go before the entire House for amendments and a vote. This webinar will delve into the House Finance Committee's proposal, including key changes relative to the Governor's proposal and to the State's current operating budget.

#### **Reviewing the Senate's Proposal**

#### Monday, June 12, 10:30am to 12:00pm

The Senate's version of the State Budget, produced by the Senate Finance Committee before going to the full Senate for any final amendments and a vote, will be heading to a Committee of Conference with members of the House of Representatives. The Committee of Conference will work to produce a final version of the State Budget to present to both the House and the Senate. This webinar will unpack key differences between the House's and Senate's proposals, and include comparisons to the Governor's proposal and the State's current operating budget.
