

Monthly Nonfarm Payroll Employment and the Consumer Price Index-Urban



MEDIAN HOUSEHOLD INCOME IN NEW HAMPSHIRE







- Median income for all household sizes was about \$97,000, according to data collected during 2023
- Average New Hampshire household size was 2.39 people during 2023
- Almost 16 percent had incomes at or above \$200,000 in 2023
- About 1 in 4 New Hampshire households had incomes below \$50,000 in 2023 data
- About 11 percent had incomes below \$25,000 in 2023
- 2023 poverty thresholds were \$15,852 for a single person under 65, \$24,526 for a three-person household with one child



PER CAPITA PERSONAL INCOME GROWTH BEHIND REGION SINCE COVID-19 PANDEMIC

- Inflation-adjusted personal income growth was much stronger in 2023 than in 2022, matching median household income patterns
- Patterns of personal income growth similar, but not exactly the same, in New Hampshire as in all New England from 2018 through 2023
- Pace of estimated personal income growth in New Hampshire is about the same as New England in the first three quarters of 2024





2019 TO 2023





LABOR FORCE AND EMPLOYMENT AMONG NEW HAMPSHIRE RESIDENTS



UNEMPLOYMENT RATE AT 2019 LEVEL, BROADER MEASURE SLIGHTLY LOWER




















MEDIAN MONTHLY PRICE OF A TWO-BEDROOM UNIT IN 2024: \$1,833

Child Care Tuition Prices for Center-Based and Family Child Care for Infants and Toddlers



NEW HAMPSHIRE POVERTY RATES OVER TIME







Percentage Living in Households in Which It Has Been Somewhat or Very Difficult to Pay for Usual Household Expenses During the Last Seven Days







Twelve-Month Rolling Averages of Monthly Cash Receipts to the General and Education Trust Funds Relative to Prior Year












SFY 2024 SURPLUS ENABLED BY GROWTH IN TWO TEMPORARY REVENUE SOURCES



General and Education Trust Funds Revenues Excluding Statewide Education Property Tax, New Hampshire, July-December State Fiscal Year 2025, Cash Basis





Revenue by Tax Year, Percentage of Revenue Total from These Two Taxes, Using Department of Revenue Administration Annual Reports for Revenue Split







Corporate Profits Adjusted for Inventory Valuation and Capital Consumption,




NEW HAMPSHIRE BUSINESS PROFITS TAX PAID AND NUMBER OF FILERS, TAX YEAR 2022


BPT FILER TYPES IN TAX BASE

MORE THAN HALF OF BPT REVENUES FROM COMPLEX, COMBINED-REPORTING FILERS





KEY TAKEAWAYS

- New Hampshire economy is performing well overall, although income growth may be more limited in 2024 than in 2023 relative to inflation
- About 98,000 Granite Staters have poverty-level incomes, and poverty may be rising among older adults
- Nearly one in three adults reported difficulty affording usual household expenses, and key cost increases limit household ability to engage in the economy otherwise
- Key factors holding back growth in the labor force and economy: housing affordability, child care affordability and access, and long-term demographic trends
- Migration has supported population growth, and education can support long-term upskilling for the workforce
- State revenues are declining overall due to both external factors, such as corporate profits and interest rates, and policy choices that have reduced State revenue
- Economy and State revenues subject to considerable uncertainty in next two years due to wide variety of potential global and national economic and policy outcomes
