
NEW HAMPSHIRE'S ECONOMY, HOUSEHOLD INCOME, AND LIVING COSTS

Monthly Nonfarm Payroll Employment and the Consumer Price Index-Urban





LABOR FORCE AND EMPLOYMENT AMONG NEW HAMPSHIRE RESIDENTS









Child Care Tuition Prices for Center-Based and Family Child Care for Infants and Toddlers





- Average hourly wage increased 41% from 2015 to 2024*








MEDIAN MONTHLY PRICE OF A TWO-BEDROOM UNIT IN 2024: \$1,833







NEW HAMPSHIRE HOUSEHOLDS BY INCOME GROUP, 2023



- Median income for all household sizes was about \$97,000, according to data collected during 2023
- Average New Hampshire household size was 2.39 people during 2023
- Almost 16 percent had incomes at or above \$200,000 in 2023
- About 1 in 4 New Hampshire households had incomes below \$50,000 in 2023 data
- About 11 percent had incomes below \$25,000 in 2023
- 2023 poverty thresholds were \$15,852 for a single person under 65, \$24,526 for a three-person household with one child
- About 98,000 Granite Staters (7.2 percent) were in poverty during 2023


MEDIAN HOUSEHOLD INCOMES HIGHER CLOSER TO METROPOLITAN BOSTON

- Pattern of median household incomes has changed slightly since COVID-19 pandemic, but not dramatically
- Fewer communities with lower-thanstatewide median incomes in southeast
- More communities with higher-thanstatewide median household incomes in Lakes Region in most recent data

Lower = -1, Higher = 1, Statistically Indistinguishable=0






NEARLY ONE IN THREE NH ADULTS REPORT DIFFICULTY AFFORDING USUAL EXPENSES

TRENDS IN THE CPI DATA

Larger Changes in Rural Communities

- Some evidence that amenity-rich communities continue to gain higher income households, but not uniformly
- Mixed evidence town-by-town, particularly in Grafton and Cheshire counties
- Median household incomes rose relative to statewide median mostly in rural small and midsized towns, tax return income gains most prevalent in Carroll County and rural communities in both northern and western New Hampshire
- Largest percentage increases and decreases in SNAP enrollment were in rural northern and western communities (top five increases in Coos and Cheshire), Coos also had largest free and reduced-price school meal increases (Dummer, Shelburne, Pittsburg, Stark) while communities with more access to amenities (Ellsworth, Eaton, Enfield, Wentworth, Benton) or further south (Sharon, Harrisville, Newington) saw decreases



TRENDS IN THE CPI DATA

Wage Growth and Rental Costs Compared to Income Vary by County

- Wage gains highest in Strafford and Grafton counties year-over-year
- Between 2021 and 2025 CPI data, largest dollar value wage gains have been in Hillsborough, Rockingham, and Grafton counties
- Rental cost increases may be easing relative to renter income, but not uniformly across counties
- In Grafton, Coos, Cheshire, Sullivan, and Belknap counties, incomes for renters outpaced rental cost increases relative to the prior years, but rents required a greater percentage of renter income in Merrimack, Carroll, and Hillsborough counties





KEY FEDERAL PROGRAMS SUPPORT NEW HAMPSHIRE SERVICES

Medicaid

- Approximately \$2.464 billion expenditure in SFY 2024 from all sources, with \$1.393 billion (56.5 percent) of that total coming from the federal government, including federal "waiver" programs
- About \$427.45 million (30.7 percent) of those federal funds supported Granite Advantage ("Medicaid expansion"), which has a 90 percent federal match, required by State law for the program to continue
- About 186,000 Granite Staters accessed health care through the program at the end of December 2024

- Federal transportation aid, through a wide variety of programs
- Education aid portion of special education aid, school meals, professional development
- Water pollution and infrastructure funds, clean and drinking water programs
- Supplemental Nutrition Assistance Program (SNAP)

- Temporary Assistance for Needy Families (TANF)
- Low Income Home Energy Assistance Program (State Fuel Assistance Program)
